Sub:- Representation regarding the grievances of the general public of West Siang Dist. regarding the lackadaisical and step motherly attitude of the concerned Department in the Health Sector.

Respected Sir,

Apropos to the above mentioned we the Arunachal Pradesh Women Welfare Society, Aalo Unit, take this opportunity to submit this instant representation before your august self for it's kind consideration and immediate necessary action please.

That Sir, perhaps your august self is well aware that the District Hospital Aalo, West Siang Dist. A.P., was upgraded to General Hospital, Aalo, in the year 2014, the entire inhabitants of West Siang District (except for foothill areas) and adjoining inhabitants of the areas of Siang and Upper Siang Districts to West Siang District are totally dependent upon it, thereby clearly indicating it's **strategical importance** and which because of it's **strategic location** in normal cases as well as emergency cases the inhabitants of the abovementioned areas are totally dependent on it.

That Sir, even inspite of being upgraded to General Hospital, the infrastructure as well manpower is far from satisfactory and not upto the mark. While 'healthcare' being one of the prime concerns and also one amongst the basic fundamental needs of today. Still General Hospital, Aalo, lacks from basic needs of the day, however, due to it's **strategic location** as above explained even inspite of insufficient Doctors and inadequate facilities these lakhs of population who unable to approach costly Private Clinics and due to communication bottleneck having no other options but to depend upon it and as such it being the lifeline of lakhs of population and till date due to such a sorry state of affairs, it resulting in innumerable fatal incidents some reported and many gone unreported, including the very recent incident which being reported in almost all the local dailies of Arunachal Pradesh.

That Sir, this sorry state of affairs causing immense woes to the **poor inhabitants** who having no other option but to totally depend upon General Hospital, Aalo, it speaks in volumes the lackadaisical and step motherly attitude of the concerned Health Department in the Health Sector which inspite of being well acquainted with the facts and circumstances and the ground realities choose to turn themselves away from these serious issues. And the question of these deprived lakhs of inhabitants who are to depend upon General Hospital, Aalo, **WHY???**

Therefore Sir, vide this instant representation we most humbly beg before your august self to fulfill the immediate requirements of General Hospital which are as below mentioned-

1. ENT Doctor.
2. Anesthesiologist Doctor.
