As you are aware, Bini Tudum was seriously injured when an Indian Air Force (IAF) fighter plane dropped a bomb during one of its regular drills over Ruyu village in Dollungmukh circle of Kamle district on June 8.

Tudum is currently admitted at the Tomo Riba Institute of Health Medical Sciences (TRIHMS) in Naharlagun and is struggling with financial problems.

So far there has been no word from the state government regarding financial assistance to the retired SSB soldier.


Therefore, the Arunachal Pradesh Women's Welfare Society (APWWS) request the state government to extended financial support to Bini Tudum.

During a recent visit by the members of APWWS, we were informed that neither the state government nor the IAF has come forward with offer of medical help.

We request you to kindly parley with the IAF so that Tudum, who is nearly 80 years is granted financial support for treatment as well as compensated adequately for the losses incurred.

We also request you to take up with the IAF regarding killings and injuries of animals during the drills.




