Through tears, the grieving mother said, "Madam, you all are mothers. I haven't slept or eaten properly, thinking about how my daughter was killed like a dog. We are so poor that we cannot afford to care for her three children. My daughter worked tirelessly to take care of her family, and now her youngest son, just 2 years old and still breastfeeding, is left without a mother. The second son is four years old, and the eldest daughter has completed

ten. My other daughter was present in the house when my son-in-law murdered my daughter. I want justice for my late daughter and her children. I appeal to you all to ensure that he does not come out of jail."

The victim's younger sister, who was present in her elder sister's house on the day of the incident, also came

forward to share her account. The team observed fear in her voice and demeanor as she narrated how her elder sister was beaten by her brother-in-law.

After counseling the family and listening to their grief, the victim's mother expressed her gratitude, saying, "Now

we have the courage, thanks to your visit."

The team also met the victim's three children, who are now left without a mother. Regarding the future of these three children, the team informed the Child Welfare Committee, Yupia, Papum Pare District, to ensure their well-
